Repair , replace freezer.</p> <p>At the time of inspection observed at two door refrigerator #2 PC 636223 lost flexibility resulting in poor sealing. Replace refrigerator gasket.</p> <p>CODE REFERENCE: 64E-11.003(4). Equipment and utensils must be properly designed, constructed, and in good repair.</p>
<p>Violation #54. Garbage & refuse disposal At the time of inspection observed at the dumpster broken drain plug. Replace drain plug.</p> <p>CODE REFERENCE: 64E-11.003(5). Garbage shall be disposed of to prevent vector harborage. Trash cans will be durable, cleanable, leak proof, insect and rodent resistant, and non-absorbent. Outside storage area shall be of a smooth, non-absorbent material and sloped to a drain.</p>
